Know YourRole Campaign

The "Know Your Role" Campaign is a Linn County CAN initiative that helps community members identify actions they can take to decrease the likelihood of child abuse and neglect.

Linn County CAN believes that each member of the community has a role to play in protecting children. Everyone can be a part of the solution in preventing child abuse in Linn County, Oregon.

What Parents/Caregivers CAN Do:

- Teach your kids the proper names for their body parts. This gives children the tools to tell you when something is wrong.
- Learn about normal childhood development.
 - 1. <u>CDC Milestones</u>– Helps you understand what skill and behaviors your child is developing.
 - 2. <u>www.loveisrespect.com</u> Help your teen learn about healthy relationships.
- Find your village. Build a support system with friends, family members and neighbors you trust.

You can also find support by joining a parenting peer-support group or signing up for a parenting class.

● ● What Neighbors CAN Do:

- Become educated on the epidemic. Contact CAN at (541)926-5432 to be connected to a local training.
- Be a member of someone's village. Support families you know by:
 - 1. Inviting a family over for dinner
 - 2. Offering to babysit
 - 3. Sharing your child's gently used clothes, toys, etc.
 - 4. Volunteering with an organization that serves youth

Speak up. If you suspect a child is being abused or neglected, call the hotline below or your local police and file a report. It is not your job to collect all the evidence, but it is your responsibility to say something. When children are being abused or neglected, they are counting on an adult to step up and say something.

How To Report



Oregon has one central line to report child abuse and neglect 24/7.

What Professionals CAN Do:

- Create a youth safety policy. Most child sexual abuse happens because predators have an opportunity to be alone, uninterrupted with a child. Contact CAN to learn how you can create a youth safety policy that protects children.
- Ensure your personnel policy supports
 working parents. Employers may
 contact CAN to find out how to make
 simple personnel policy changes that
 support working parents, such as, having
 an emergency day-care plan.
- Be trauma informed. Many people have experienced trauma. Taking a Trauma Informed Care training explains the effects of trauma on the brain, how one can unintentionally activate someone's trauma and practices you can implement to avoid re-traumatization.
