

## FOR IMMEDIATE RELEASE: UNITED WAY ANNOUNCES FEDERAL EMERGENCY FOOD AND SHELTER GRANTS & CARES FUNDING

Linn, Benton, & Lincoln Counties, OR - May 5, 2020 -

The United Way of Linn, Benton & Lincoln Counties announced today that local applications for the Emergency Food and Shelter National Board Program are now open. The deadline for applications is May 15, 2020. Each county is allotted the following amount for federal assistance:

Linn County: \$52,641Benton County: \$29,674Lincoln County: \$18,829

Additionally, The Emergency Food and Shelter Program (EFSP) was appropriated supplemental funds under the Coronavirus Aid, Relief, and Economic Security (CARES) Act in FY 2020 in the amount of \$200 million nationally. Local amounts allotted per county are as follows:

Linn County: \$75,050Benton County: \$42,307Lincoln County: \$26,844

The Emergency Food and Shelter National Board Program was created in 1983 to supplement the work of local social service organizations within the United States, both private and governmental, to help people in need of emergency assistance.

Funded by the Federal Emergency Management Agency (FEMA), the Emergency Food and Shelter Program (EFSP) is designed to help nonprofit and local government agencies feed the hungry, shelter the homeless and prevent hunger and homelessness for thousands of people facing non-disaster emergencies. This public/private partnership carries through to the grassroots level as local boards determine how to use EFSP funds in their communities.

As the local administrator of this program, United Way of Linn, Benton & Lincoln Counties is responsible for:

- Coordinating a process to advertise and solicit applications for funding
- Recruiting members for the local EFSP board
- Facilitate the funding allocation process. United Way acts as a liaison between the National EFSP local recipient organizations for all reporting and monitoring purposes.

The local EFSP Board as managed by United Way is designed to ensure cooperation between agencies and allocation of funds to the neediest areas. The local board is composed of representatives knowledgeable of local service needs and will prioritize funding allocations accordingly.
